QUALIFIED AND INTERESTED SERVICE PROVIDERS ARE HEREBY INVITED TO SUBMIT QUOTATIONS FOR FREQUENCY MODULATION (FM) SYSTEMS FOR HEARING IMPAIRED LEARNERS ATTENDING SPECIAL AND MAINSTREAM SCHOOLS ACROSS THE PROVINCE

The Directorate Inclusive Education has identified a need to procure FM System for learners attending special and mainstream schools across the province of the Eastern Cape. The FM systems will be managed by Audiologists and Speech Language Therapists employed at District Offices and Special schools. The Eastern Cape Department of Education therefore need a Service Providers who will provide FM Systems (assistive devices) for hearing impaired learners attending special and mainstream schools across the province.

2. PLANNED OUTCOMES /PURCHASING OF ASSISTIVE DEVICES (FM SYSTEM)

Purpose of the FM systems (Assistive Device for hearing).

1. The FM Systems are wireless assistive hearing devices that enhance the use of hearing aids and/or cochlear implants.
2. To assist learners who are hard of hearing but do not wear hearing aids, in particular over distances and in noisy environments such as classrooms.
3. Frequency modulation is a wireless transmission method used to transmit the sound from the educator to the learner.

3. TERMS OF REFERENCE

1. The FM systems will be provided to all learners who are fitted with hearing aids and/or cochlear implants and who may have auditory processing or listening difficulties;
2. The Service Provider must provide FM systems according to the specifications below;

3. The Service provider must be able to provide free training on the FM systems provided; and
 4. The Service Provider must provide information to compile a report to the Eastern Cape Department of Education: Inclusive Education Directorate after the training.
 5. The service provider must have a **permanently qualified Audiologist** in their company with at least 5 years of working experience.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
